On 10/13/18 at approximately 1029 hours, an Officer contacted Sandi R. Edenshaw, age 34. She was served a summons ordering her to appear in court. She was charged with a theft.

On 10/13/18 at approximately 1051 hours, Officers responded to the 1700 block of Second Avenue due to a report of a suspicious person. Toni R. Sanderson, age 38, was contacted on the Third Avenue Extension after she ran through the woods. She was in contact with another female she was court ordered not to have contact with. She was arrested for Unlawful Contact in the First Degree, Violation of Conditions of Release and an outstanding warrant. She was transported to the state jail and held on no bail.

On 10/13/18 at approximately 152 hours, an Officer contacted Leslie B. Verney, age 59 at a midtown apartment complex for trespassing. Mr. Verney had been court ordered not to consume alcohol. Mr. Verney had an open bottle of hard alcohol and was intoxicated. He was arrested for Violation of Conditions of Release, transported to the state jail and held on \$250.00 bail.

On 10/14/18 at approximately 1711 hours, Officers responded to north city limits for a report of a drunk driver driving a blue Toyota 4-Runner. The vehicle was stopped in the 4000 block of Tongass Avenue. Officers contacted Carolyn Eckholm, age 39, who was identified as the driver. She was arrested for Driving Under the Influence, transported to the state jail and set to be released on her own recognizance.

On 10/16/18 at approximately 0705 hours, Cameron S. Knight, age 26, came to the police department and was arrested on an outstanding probation warrant. He was transported to the state jail and held on no bail.

On 10/16/18 at approximately 2046 hours, Officers responded to a motel for a report of people in a verbal fight. Officers contacted Joseph Volpi, age 38, who was intoxicated. Mr. Volpi was arrested for violating his conditions. Mr. Volpi was found to be in possession of heroin. He was also charged with Misconduct Involving a Controlled Substance in the Fourth Degree. Mr. Volpi was transported to the state jail and held on no bail.

On 10/18/18, in furtherance of an ongoing investigation in which approximately 59.2 grams of Methamphetamine had been seized bound for Ketchikan from Washington State, Officers of the Ketchikan Police Department, the United States Postal Inspection Service, the Drug Enforcement Administration, and the Ketchikan Airport Police contacted Tonya M. Moody, age 36, upon her arrival in Ketchikan. Ms. Moody was found to be in possession of approximately 90.4 grams of Methamphetamine. Ms. Moody also claimed responsibility for the seized shipment of Methamphetamine. She was transported to the state jail where she was booked on two counts of Misconduct Involving a Controlled Substance in the Second Degree and held on no bail.
