On 09/17/18 at approximately 1039 hours, Officers responded to the 4400 block of North Tongass Highway due to a report of a white Dodge pickup driving erratic. Officers contacted Ellen Williams, age 57, as the operator of the pickup. Ms. Williams was arrested for Driving Under the Influence. She was transported to the state jail and set to be released on her own recognizance.
