On 04/10/19 at approximately 0055 hours, Officers conducted a traffic stop on a vehicle in the 2400 block of Tongass Avenue for speeding. Juan Galvan, age 23, was found to be intoxicated and was arrested for Driving Under the Influence. He was later remanded to the state jail and charged with DUI and Refusal to Submit to Chemical Test. Mr. Galvan was set to be released on his own recognizance.

On 04/10/19 at approximately 1010 hours, Officers contacted Mitchell Volpi, age 35, at the 300 block of Main Street. Mr. Volpi had an arrest warrant for Violation of Conditions of Release. He was arrested, transported to the state jail, and held on \$5000.00 bail.

On 04/10/19 at approximately 1214 hours, Officers contacted Jesse Grant, age 29, at the 2400 block of 4th Avenue. Mr. Grant had an arrest warrant for Assault in the 1st Degree. He was arrested, transported to the State jail, and held on \$10,000 bail.

On 04/11/19 at approximately 0020 hours, Officers responded to a residence on Woodside Drive for a complaint of a person drunk and disorderly. Officers contacted Felicia A. Burton, age 42, who was intoxicated and combative. Ms. Burton was arrested for Criminal Mischief in the 5th Degree – Domestic Violence. She was transported to the state jail where she was held without bail.

On 4/11/19 at approximately 0100 hours, Officers responded to a residence on Woodside Drive for a domestic disturbance. Upon arrival, Officers contacted Franklin J. Dubose, age 23. Mr. Dubose had a \$25,000.00 extraditable warrant out of Texas for Sexual Assault. Mr. Dubose was arrested and transported to the state jail where he was held on a new charge of Fugitive from Justice pending extradition to Texas.

On 04/13/19 at approximately 1320 hours, Officers responded to Front Street due to a report of a male climbing over a fence into the construction zone creating a hazard then running east into traffic. Officers contacted Gary R. Brown, age 49, in the 400 block of Stedman Street. He was arrested for Disorderly Conduct, transported to the state jail, and set to be released on his own recognizance.

On 04/14/19 at approximately 1902 hours, Officers contacted a van in a midtown grocery store parking lot. The driver was reported to possibly be driving under the influence. Crystal R. Skultka, age 29, and Felicia A. Burton, age 42, were contacted as passengers. Both had been consuming alcohol and had conditions ordering them not to drink alcohol. Both were arrested for Violation of Conditions of Release. They were transported to the state jail and both held without bail.

On 4/13/2019 at approximately 1041 hours, Officers responded to the 4000 block of Don King Road for a report of a theft. Officers contacted Angelina Guilbeau age 29. She was arrested for Theft in the 4th Degree and Criminal Trespass in the 2nd Degree. She was transported to the state jail and held on \$250 bail for each charge for a total of \$500. During a search incident to arrest officers found evidence of another theft and trespass. She was additionally charged with another Theft in the 4th Degree and Criminal Trespass in the 2nd Degree.

On 04/15/19 at approximately 1753 hours, Officers contacted Andrea M. Jackson, age 63, in the 2400 block of Tongass Avenue. She was served a summons with a mandatory court appearance for Theft in the 3rd Degree. The charge stems from a February 2019 investigation.

On 4/16/19 at approximately 1502 hours, Officers responded to the 500 block of Grant Street for a report of a female screaming. Officers contacted Michael Cox, age 23, and based on their investigation he was arrested for Assault in the 2nd Degree Domestic Violence and Criminal Mischief in the 5th Degree - Domestic Violence. He was transported to the state jail and held without bail.

On 04/17/19 at approximately 1517 hours, Officers responded to the 600 block of Park Avenue for a report of a male violating his conditions of release. On arrival, officers contacted Damion Mask, age 41. Based on the investigation, Mask was arrested for Unlawful Contact in the 1st Degree and Violating Conditions of Release. He was transported to the state jail and held without bail.

On 04/18/19 at approximately 2227 hours, Officers contacted Jes Boyd, age 33, in the 300 block of Main Street due to him having an outstanding summons and an arrest warrant. The summons was served to him, ordering him to appear in court for a theft charge. He was arrested for the warrant which was for multiple drug charges. He was transported to the state jail where he was held on \$20,000.00 bail.

On 04/21/19 at approximately 2000 hours, Officers contacted Todd Edmondson, age 46, at a residence on Thatcher Way due to a report a domestic assault. The investigation revealed he injured his girlfriend by pushing her down. He was intoxicated. He had conditions of release which state he was to obey all laws and he was ordered not to consume alcohol. Mr. Edmondson was arrested for Assault in the 4th Degree – Domestic Violence and Violation of Conditions of Release. He was transported to—the state jail where he was held without bail.

On 04/23/19 at approximately 1910 hours, Officers were dispatched to a domestic assault in the 3400 block of Baranof Avenue. Joseph K. Stone, age 28, was contacted and arrested for Assault in the 4th Degree – Domestic Violence. He was transported to the state jail and held without bail.

On 4/26/19 at approximately 2027 hours, Officers were dispatched to the 1200 block of Woodside Drive for a report of Christina Carlberg, age 42, taking the complainant's phone and throwing it on the ground causing approximately \$1,000.00 in damage. Mrs. Carlberg was arrested and transported to state jail where she was booked on one count of Criminal Mischief in the 3rd Degree-Domestic Violence and held without bail.

On 04/26/19 at approximately 2058 hours, Officers responded to an apartment in the 300 block of Bawden Street due to a report of a domestic disturbance. Benjamin Sheyan, age 71, was contacted. He was arrested for Assault in the 4th Degree – Domestic Violence for assaulting his girlfriend. He was transported to the state jail where he was held without bail.

On 04/27/19 at approximately 0223 hours, Officers conducted a traffic stop on a vehicle for speeding and contacted Brian Updike, age 34, as the operator. Officers observed him to be under the influence of alcohol. Mr. Updike submitted to and failed field sobriety tests. He was arrested for Driving Under the Influence and later transported to the state jail where he was held on \$1000.00 bail.

On 04/27/19 at approximately 1514 hours, Officers conducted a traffic stop on Miller Ridge Road. The driver, Ralph H. Wall, age 58, was issued a misdemeanor citation for No Motor Vehicle Liability Insurance. He was ordered to appear in court at a later date.

On 04/27/19 at approximately 2006 hours, Officers contacted Joni Vrell, age 57, at the 300 block of Main Street. A routine background check showed Ms. Vrell to have valid conditions of release not to consume alcohol. Ms. Vrell admitted drinking alcohol and she was arrested for Violation of Conditions of Release. She was transported to the state jail and held on \$250.00 bail.

On 04/28/19 at approximately 1353 hours, Officers responded to the East Street promenade due to a report of a fight. After further investigation, Joseph A. Harris, age 21, was arrested for Furnishing Alcoholic Beverages to Persons Under 21. He was transported to the state jail, booked and was set to be released on his own recognizance. Sharlee R. Polty, age 19, was issued a citation for Possession by Persons Under 21 with a mandatory court date.
